

How to Add New HCSP Employees in Sponsor Web

Employers may only add new employees to the Health Care Savings Plan (HCSP).
Once a new employee is added, you may remit payroll contributions for them.

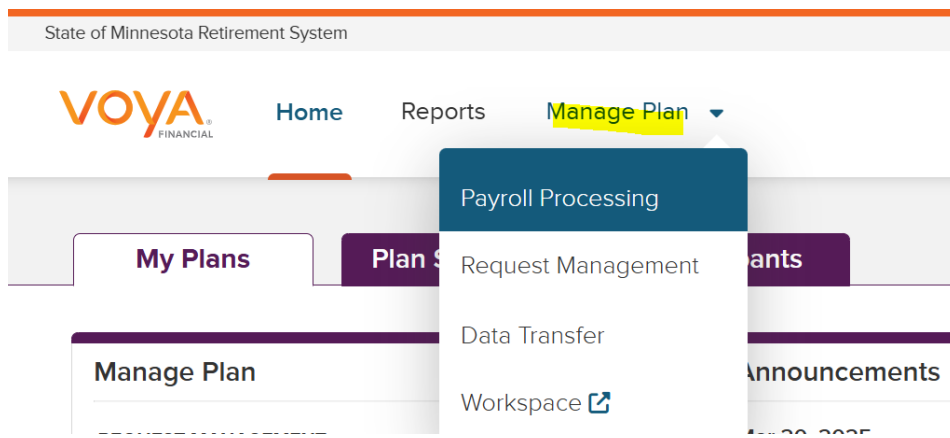
Employers may not add new employees to the Minnesota Deferred Compensation Plan (MNDCP).
An employee who wants to enroll in the MNDCP must complete a MNDCP Enrollment form.

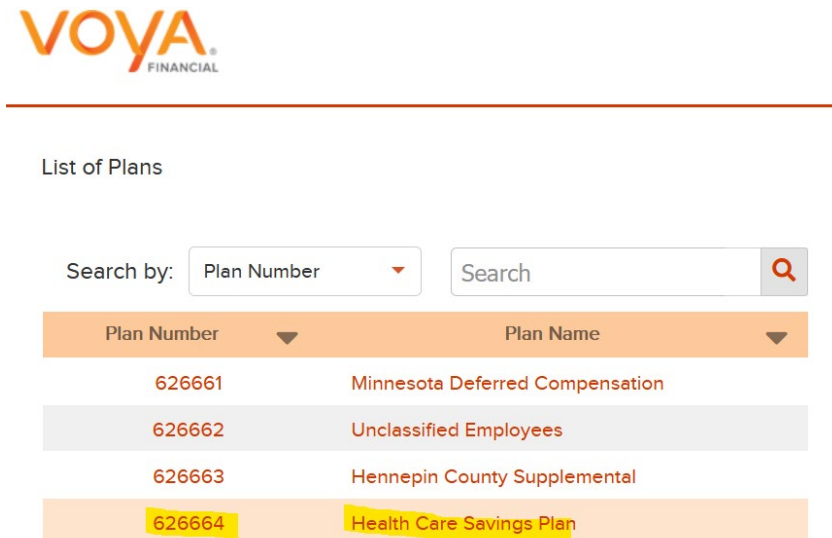
